PERSONAL INFORMATION COLLECTION STATEMENT

Global e-Trading Services Limited (hereinafter referred to as "Ge-TS", "we", "us" and "our") values the privacy of

Personal Data and this statement (hereinafter referred to as the "Statement") serves as a notification

pursuant to the requirements of the Personal Data (Privacy) Ordinance (Cap. 486 of the Laws of Hong Kong).

Under the Statement, unless the context otherwise requires, the following words and expression shall have the following

meanings:

"Services" means the Government Electronic Trading Services provided by Ge-T5 in accordance with the agreement between the Government of the Hong Kong Special Administrative Region and Ge-T5.

"Personal Data" means the data that may be collected or held by Ge-T5 from time to time in connection with

e registration and establishment of user accounts or the Services.

"Data Subject(s)" means the user(s) of the Services.

Purposes of Collection and Use of Personal Data

When Data Subject(s) use the Services, we may, in the course of and in relation to provision of the

Services, collect and process Personal Data.

The provision of Personal Data is mandatory for subscribing Ge-TS's Services for processing traderelated documents under the agreement between the Government of the Hong Kong Special Administrative Region and Ge-TS. If a Data Subject fails to provide necessary information and particulars, we may be unable to provide the Services in full and carry out related activities.

We shall have the rights to collect, hold, process and use a Data Subject's Personal Data in

accordance with this Statement

With regard to the use of the Services, we may collect and use Personal Data for one or more of the following

- processing applications for the Services;
- providing the Services; communicating with Data Subjects or their authorized entities;
- maintaining usage or transaction history of Data Subjects for evaluating and improving the Services; marketing the Services from time to time by Ge-Ts or its affiliated companies; distributing publications of Ge-Ts or its affiliated companies; complying with laws, rules, regulations, codes of practice or guidelines;

- performing legal proceedings, including collecting overdue amounts;
- other purposes expressly agreed between Ge-TS and Data Subject(s); any lawful purposes for assisting in law enforcement and investigations; and any other ancillary purposes directly relating to the purposes listed above.
