Purposes of Collection and Use of Personal Data

When Data Subject(s) use the Services, we may, in the course of and in relation to provision of the Services, collect and report of the Services and Services an

process Personal Data.

The provision of Personal Data is mandatory for subscribing Ge-TS's Services for processing trade

trade and between the Government of the Hong Kong Special Administrative Region and documents under the agreement between the Government of the Hong Kong Special Administrative Region and Ge-TS. If a Data Subject fails to provide necessary information and particulars, we may be unable to provide the Services in full and carry out related activities

We shall have the rights to collect, hold, process and use a Data Subject's Personal Data in accordance with this Statement

With regard to the use of the Services, we may collect and use Personal Data for one or more of the following purposes:

- performing legal proceedings, including collecting overdue amounts; other purposes expressly agreed between Ge-TS and Data Subject(s); any lawful purposes for assisting in law enforcement and investigations; are any other ancillary purposes directly relating to the purposes listed above.

 any law enforcement or regulatory authority; and
 any person under a duty of confidentiality to any members of Ge-TS and its subsidiaries (including accountants, legal advisers and other advisers).
 Transfer or disclose of Personal Data will only be made to one or more of the parties specified above. We shall not disclose of the parties of Data and the parties of the parti disclose or transfer Personal Data to any other party not specified above without the express consent of Data Subject(s)

All Personal Data will be retained for the duration as may be necessary for the above-mentioned purposes and for as long as required by applicable laws
