#### Hong Kong Imports and Exports Classification List (Harmonized System)

##### Amendments for 2025

The Census and Statistics Department ("C&SD") has announced that the amendments to the Hong Kong Imports and Exports Classification List (Harmonized System) in 2025 will take effect on 1 January 2025. We will perform the necessary HS Code update to our platform for such changes after 31 December 2024. You are reminded to input the correct arrival or departure dates for their shipments as the basis for determining the correct set of HS Codes to be used.

- **Please be reminded to use the 2024 HS Codes in Import and Export Declarations for 2024 shipments which are lodged before 14 January 2025.**
- **From 15 January 2025, the new 2025 HS Codes are required to be used in all declarations regardless of the shipment dates.**

#### 香港進出口貨物分類表（協調制度）2025 年之修訂

香港進出口貨物分類表（協調制度）2025 年之修訂將於 2025 年 1 月 1 日起生效。客戶於 2024 年 12 月 31 日以後首次登入軟件時，程序即會自動執行更新協調制度編號的版本。客戶在遞交報關前應查核及準確地填寫貨物抵港或離港的日期，該日期將用作決定報關時所採用之協調制度貨品編號，屆時請客戶注意。

- **在 2024 年內抵港或離港的貨物，並於 2025 年 1 月 14 日或之前遞交的進出口報關均應使用 2024 年協調制度貨品編號。**
- **貨物由 2025 年 1 月 15 日起何時抵港或離港，在遞交報關時必須使用 2025 年協調制度貨品編號。**
